#### Resolution #5274-3

Whereas, Cleburne County, Alabama (the "County") has been allocated funds in the amount of \$474,366.26 by the U.S. Department of Treasury ("Treasury") from the Local Assistance and Tribal Consistency Fund ("LATCF"), established by Section 605 of the Social Security Act, as added by Section 9901 of the American Rescue Plan Act of 2021; and

Whereas, the LATCF funds allocated to the County may be expended by the County for governmental purposes; and

Whereas, to receive the LATCF funds allocated to the County, an authorized representative of the County must submit a request for funding to Treasury on or before January 31, 2023; and

Whereas, the Cleburne County Commission (the "Commission") has determined that receipt of these funds for expenditure by the County for governmental purposes will inure to the benefit of the citizens of this County.

Now, Therefore, be it resolved by the Commission as follows:

The Chair of the Commission is hereby authorized to request or to designate another County official to request the County's allocated share of LATCF funds in accordance with the procedures established by Treasury. The authority delegated herein includes the authority for the Chair, or his or her designee, to execute agreements or other documents necessary to request and receive this allocation.

## Resolution #5276

Whereas, the County has received a Coronavirus State and Local Fiscal Recovery Fund ("SLFRF") award under the American Rescue Plan Act ("ARPA funds") from the U.S. Department of the Treasury ("Treasury"), which, in accordance with the Final Rule issued by Treasury on January 6, 2022, has been duly designated as revenue replacement funds ("revenue replacement funds"); and

Whereas, these public funds may be used for the purpose of providing government services, including support of water/sewer infrastructure; and

Whereas, the Cleburne County Commission has previously agreed to allocate a portion of its ARPA Funds for Cleburne County water projects;

Whereas, Roger Rendleman, Consultant for Investing in Alabama Counties (IAC), has provided an agreement for the County Commission and Cleburne County Water Authority (CCWA), designating CCWA as a subrecipient of the funds;

Now Therefore, be it resolved that the Cleburne County Commission authorizes Ryan Robertson, Chairman to sign the agreement on behalf of the Commission.

Cleburne County Emergency Manager, Crystal Cavender, informs the Commissioners that prior to the removal of the weather sirens, a transfer of property form must be signed by the appropriate Fire Chief.

# Resolution #5278

Whereas, the Cleburne County Commission is aware that a number of weather sirens are no longer in working order and are obsolete, due to unavailability of replacement parts;

Whereas, the expense for the County would be prohibitive to replace the weather sirens, along with the fact that many parts are no longer available; and

Whereas, the Cleburne County Emergency Management Director, was tasked with communicating with the individual fire departments regarding the intentions of each, to repair or remove the weather sirens;

Whereas, the majority of the fire departments opted for removal;

Now Therefore, be it resolved that the Cleburne County Commission agrees to have the obsolete and inoperative weather sirens, chosen for removal, taken down 3 at a time at the cost of \$450 per unit, said cost to come from the General Fund. The fire departments must sign a letter at or before the time of removal, thereby transferring the weather sirens back to the Cleburne County Commission.

# Resolution #5280

Whereas, the Cleburne County Commission authorized an employee hourly rate increase reflecting a plan obtained through a comprehensive pay study;

Whereas, between the date of the Commission's Resolution authorizing the increase and the date of implementation, the Cleburne County Sheriff requested an additional amount be added to certain Sheriff's Department employee's hourly pay;

Whereas, the increase was added to the amount of the initial adjustment given by the pay study, without the knowledge or approval of the Commission;

Whereas, the unauthorized portion of the increase was applied to those employee's hourly pay rate from the first paycheck in April 2022 and continuing until the last paycheck in September 2022, at which time it was administratively halted to prevent additional improper payments;

Whereas, the unauthorized portion of the affected employee's pay must be recouped by the Cleburne County Commission. Methods of recoupment, to be selected by each employee, include the following:

- 1) A lump sum withholding from the Employee's Regular Pay
- 2) Withholding at a rate that the Employee authorizes (not to exceed level repayment over the course of 6 months)
- 3) Repayment using a leave cash out of vacation or comp time
- 4) Any combination of the options listed in 1-3 above.

Now therefore be it resolved by the Cleburne County Commission that any and all amounts paid to Sheriff's Department employees as a result of the Sheriff's unauthorized increase in certain salaries must be recouped from the affected employees. Authorized methods of recoupment are set forth hereinabove, to be exercised at the option of each individual employee.

# Resolution #5281

Whereas, the pay study plan received from Condrey & Associates and authorized by the Cleburne County Commission did not include any provisions for uncertified Sheriff's Department Deputies;

Whereas, there have been uncertified officers hired by the Sheriff's Department since the study took place;

Whereas, the Commission is aware that there should be a pay difference between uncertified officers and certified officers;

Now Therefore, be it resolved that the Cleburne County Commission authorizes a pay grade step change from Pay Grade 16, Step A to Pay Grade 16, Step B when the officer becomes certified or if a certified officer is hired, the employee will begin at Pay Grade 16, Step B.

- A. County Administrator Lisa Copeland is absent, but prepared a list of updates as follows:
  - A calendar has been created through Outlook that can be used by Administrative staff and Department Heads.
  - I am currently working, with the Sheriff's Dept., on a contract for vehicle maintenance. This will then be sent to Jason for him to edit.
  - We recently had a fraudulent check presented against one of our bank accounts. The
    bank caught the issue this time. Due to increasing threat of fraud, Metro Bank is working
    to get our accounts on a Positive Pay system. Meaning we will be required to send a file
    to them when we write any checks. The file will contain information such as vendor,
    check number, and check amount. I just wanted the commission to be aware that this is
    in the works.

Considerations for the recoupment resolution

1) Start date of repayment?

2) If employee doesn't specify the methods (as laid out in a letter to each employee), by the due date given, the pay back will be taken back as a lump sum?

County Attorney Jason Odom states the start date of repayment should be the first full pay period in January. If an employee does not make a decision by the deadline, then by default it will go to the repayment over a 6-month time period.
